F: Voice Repeaters

Letter intent for a 23cm Internet linked repeater on Stenbury Down, Isle of Wight has been received. A full proposal has been requested and will be processed when received. The desired callsign is GB3IL.

GB3GH: Site change application has been received. This will be covered by the fast track procedure. There were some omissions from the application and GM8LBC is helping G8DOR deal with these.

GB3EA & GB3SH: Letter of intent for a site change. Full applications have been request from the keeper.

GB3ND: A letter of intent has been received from a group wishing to re-establish a repeater in North Devon. They wish to use the callsign GB3ND. A full application has been requested.

GB3UB: An anonymous telephone call claimed that GB3UB was transmitting spurious emissions over the 70cm band. G8DOR, whilst in the area checked and found no problems.

GB3WA: Letter of intent to change antennas and mast. The new installation should remain within the parameters of the original application or a new one will be required.

GB3YS & GB3WA: The Wessex repeater group are interested in linking these repeaters. They have asked for advice on what frequencies are recommended. Linking is usually achieved using 23cm or higher. 2E1EJL will email the frequencies used for this purpose to G8DOR who will forward them to the group.

Action 2E1EJL & G8DOR

Letter of intent for a 23cm Repeater in the Reading area has been received. G8DOR declared an interest in the project. The Chairman was happy for G8DOR to deal with the application himself.

GB3WI: Some problems reported with band splatter. The group have adjusted power output and the problem has been resolved.

GB3FJ: Several cases of vandalism and the police have been informed. Currently on air but the feeder needs to be replaced because it has been jointed to repair the damage caused by the vandalism.

GB3MG: Currently off air. The keeper will be contacted to see if the RMC can assist him to bring the repeater back into service.

Action GW7KDU

GB3SY: After a site change it has been discovered that there are problems on the new site. The keeper wishes to move back to the old site. This will not be possible without a formal application using the fast track procedure.

Action G70BW

GB3NA: No more heard regarding complaints made about the repeater. The RA has been invited to inspect GB3NA. Post meeting note – the RA have carried out an inspection and have given the repeater a clean bill of health.

GB3HG: A number of telephone calls have been received. Firstly the keeper was confused about the RX/TX frequencies on the Site Clearance Form (SCF). The Chairman clarified these to him. G4DAX has made enquiries about the use/allocation of CTCSS frequencies as the group have a plan to link GB3HG and GB3YC and would like to use the same tone on both repeaters. There is no problem with this provided no interference is caused to any other repeater. G4DAX is to be contacted to inform him of this.

Action G70BW

GB3TP: G7OBW gave a talk to Keighley ARS about the work of the RMC. The group would like to use to a 12.5kHz frequency because of occasional interference with GB3VT. A full application will be required. An application has been received from G3ZHI for an Internet link. No copy of his validation document was included. This has been requested.

Action G70BW

The RA has requested that full details of stations being used to provide Internet links to repeaters be included on all future applications. The following data is required: -

- Input/Output frequencies of the repeater.
- Power in use by linking station.
- Gain, type, height (above ground and asl) of antenna at linking station.
- Copy of validation document for linking station.
- Permission from keeper for link.

GB3PZ: A report on this repeater has been received from the group. There have been no problems apart from a rogue transmitter causing interference. This was tracked down and everything is now working well. G7OBW declared an interest, as he is the Chairman of the UKFM Group (Western), which funds GB3PZ.

GB3WF: Email received by G7OBW. Installation of the repeater is progressing well and it is hoped that it will enter service shortly.

A letter of intent has been received from a group in Ludlow who are interested in building a 70cm repeater. They have most of the necessary equipment and have a good site available. They require logic and combiner and some technical assistance. G8LXI will provide help to the group.

G: TV Repeaters

GB3VV & GB3VW: Both repeaters are now on air.

GB3CT: Interest has been expressed in re-establishing this 23cm repeater. There are potential problems with radar at Gatwick. A full application will be requested.

Action G3VZV

A letter of intent has been received for a 10GHz unit at Kettering.

GB3EY: The group have lost their site due to Home Office objections to the repeater. They have two other potential sites one approximately 2km and the other 10.5km from the original site. There may be problems with radar sites. A site change application will be requested.

GB3VL: The power increase application has now been withdrawn.

GB3TX: The CAA has been consulted about this repeater and responded with some suggested frequencies that would suit them. They are unsuitable. Further clarification will be sought.

H: Technical Matters

The Chairman gave a report on the HerTZ Mapper software, which was recently set up at RSGB HQ. There are some differences in the plots produced by this software and those produced by the committee's proposals manager GM8LBC. The Chairman and GM8LBC will work together to resolve the differences so that the most realistic plot can be produced. Due to the time taken by the computer to produce each plot it is vital that the parameters are correct before starting.
