5: GI4BWM Review of Closedown Operator Rules

The following have been agreed with Ofcom.

- Four closedown operators, including the keeper are sufficient.
- Closedown operators are to be within reasonable travelling time.
- It is not necessary for the keeper to be the sole person permitted to restore power to a repeater but any person doing so must be a licensed amateur and authorised by the keeper on the E1 form.
- Remote power on of a repeater is permissible.

6: G8DOR: Digital Repeater ID requirements

Methods of ID for digital repeaters were discussed as some products currently on the market notably Fusion repeaters are incapable of CW id. It was decided that it is acceptable for digital mode repeaters can ID in their bit stream.

GB7LB: New Fusion repeater for the Leeds area. Possible use of an existing repeater. On hold until resolved.

GB3PZ: Completion of a proposal to change to the Fusion system awaited.

GB7YD-A: DV Awaiting delivery of custom designed combiner/duplexer to allow GB7YD-A DD and DV to use a common antenna.

GB7SR: Reports of interaction between GB7SR and GB7HM which both use DVU51 and the same colour code CC1. Investigations to check if a change of colour code will resolve the problem and will be a subject for future DMR proposals using the same channel as an existing DMR repeater.

GB3CY: Ongoing enquiries to resurrect GB3CY, a dormant 70cm analogue repeater for York.

Scotland

23cm AV repeater in Ayrshire received. To use an existing RM Channel, polarisation is horizontal.

G3YSX passed on thanks from the RSGB Board to the committee for its work. The Board would welcome suggestions from the committee for projects that would benefit from the RSGB legacy fund.

8: AOB

G7UZN raised a question about time limits between applications for NoV changes. It was decided that a minimum of six months would have to elapse between E1/NoV changes for a repeater.
