4: Report on July 15th Ofcom/RSGB/CAA meeting

South/South West England

GB3PC: Was running on batteries for a while but is now off air. Its keeper is currently out of contact.

TV Repeaters

GB3BA: Second NoV issued

GB3BH: 3.4GHz NoV not yet in service, GI4BWM to chase the group for an update.

North of England

GB3TJ: A new proposal has been received from the Tyne area for a new 70cm repeater to be co-sited with GB3HA near Hexham. The proposal is still incomplete and cannot progress until this is updated.

A request was received to re-use the callsign and channel previously used by GB3MC in the Bolton area for the Oldham area of Greater Manchester. Is not currently possible as the GB3MC is still awaiting second NoV for permanent closure. A complete new proposal is consequently needed for any progress to be made.

RSGB Board

G3YSX passed thanks to the ETCC from the RSGB board.

7: Feedback from Hamfest

A visitor to the ETCC stand had mentioned that GB3IP was still off air but that he was aware that the Keeper was making efforts to get it sorted out and hopefully it would return soon.

M1GRY had mentioned the lack of activity in the Bristol area.

There was interest shown in providing better 2M coverage on the NE coast. GI4BWM pointed out that this had been mentioned before and no obvious frequencies were available.

GB7HM was noted by G8DOR to have a very wide coverage.
